☎+1-803-335-2310 The Southwest Airlines **10-minute rule** is a crucial boarding and check-in policy that states you must be **present at the gate at least 10 minutes before your flight's scheduled departure time**. If you are not physically present by that time ☎+1-803-335-2310, Southwest may cancel your reservation, release your seat, and give it to a standby passenger. Does the 10-Minute Rule Apply if the Flight is Delayed?
