# MSD Project Clear (MSDPC) Overview & Details

- Government Utility
  - State Constitution
  - Voter Approved Charter in 1954
  - 6 Member Board of Trustees (3 City & 3 County)
- Two utilities: Wastewater & Stormwater
- 520 square mile service area
  - All of St. Louis City
  - 87% of St. Louis County
- ~1,300,000 customers
- 88 municipalities served
- 7 Treatment Plants
- 350+ million gallons per day of wastewater treated
- 4,700+ miles of wastewater sewers
- 1,800+ miles of combined sewers
- 3,000+ miles of stormwater sewers
- 4th largest sewer system in the United States (as measured by miles of sewers handling wastewater)

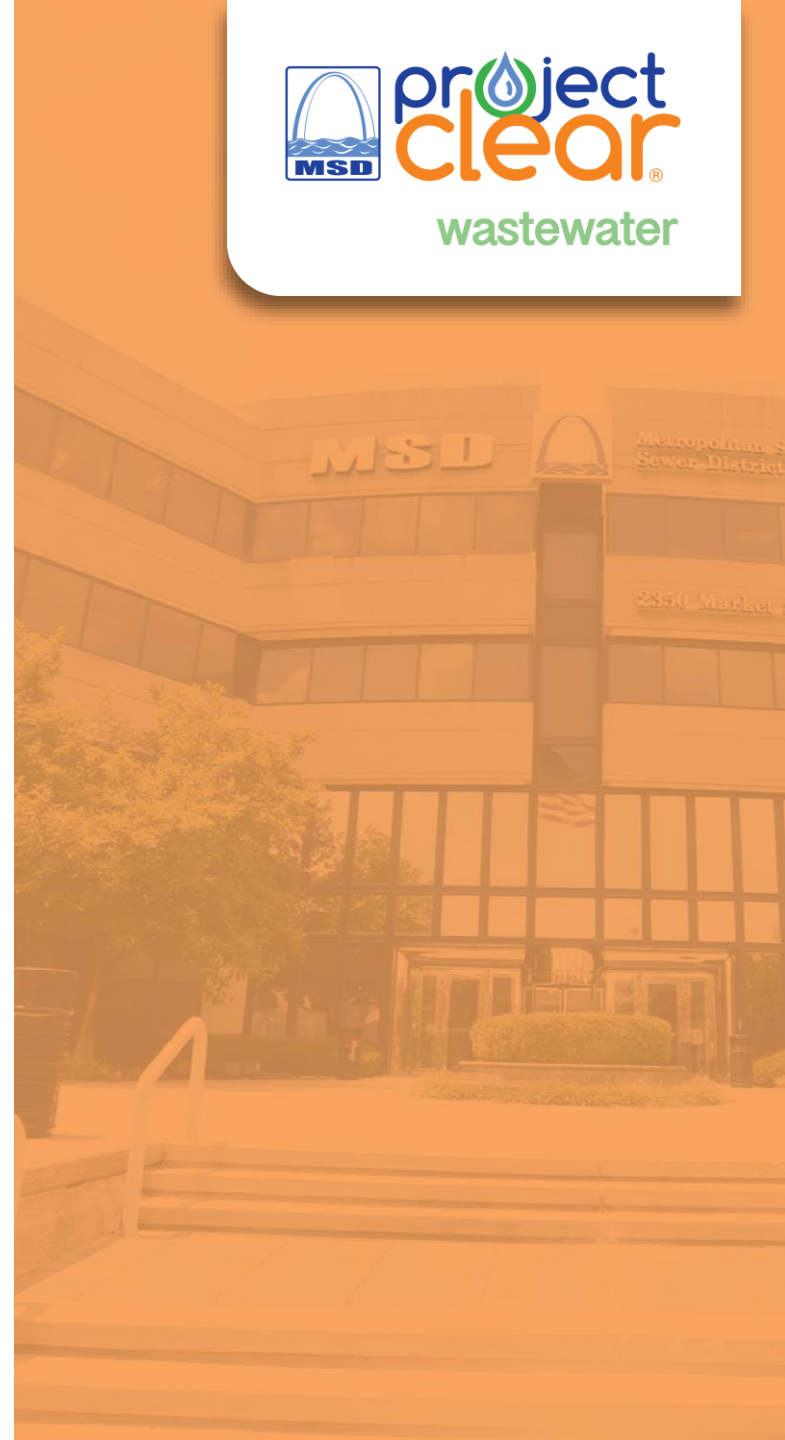

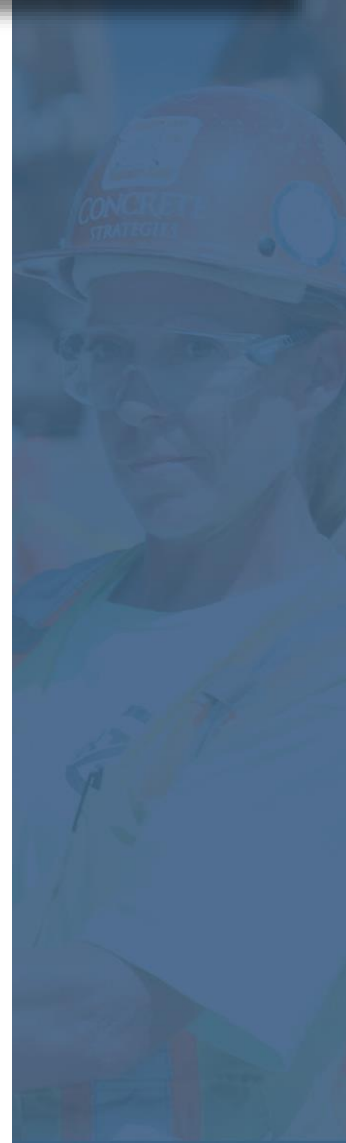

# Project Overview

- General Goal
  - Replace undersized sewers
  - Remove 1 overflow
- Project Scope
  - Replace approx. 5,000 feet of sewer
  - Average size = 10-27”
- Benefits
  - Cleaner waterways
  - Alleviate basement backups
  - Reduce instances of overcharged sewers

- Tulane-Wilbur: New Sanitary Sewer





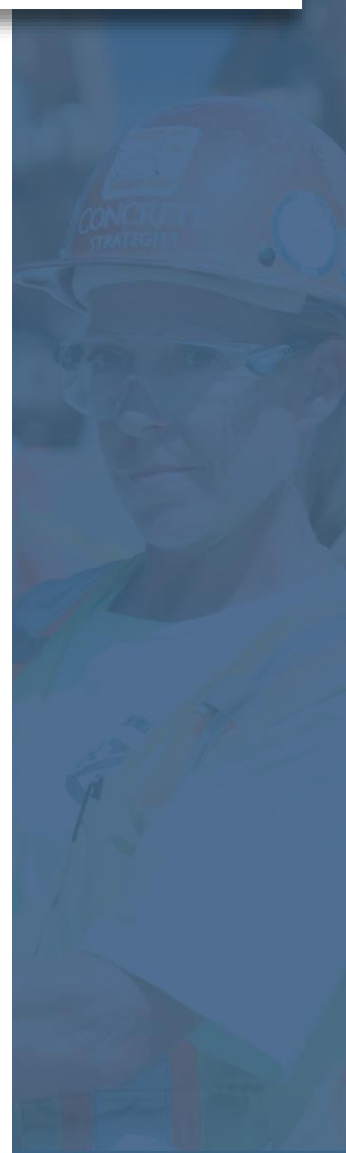

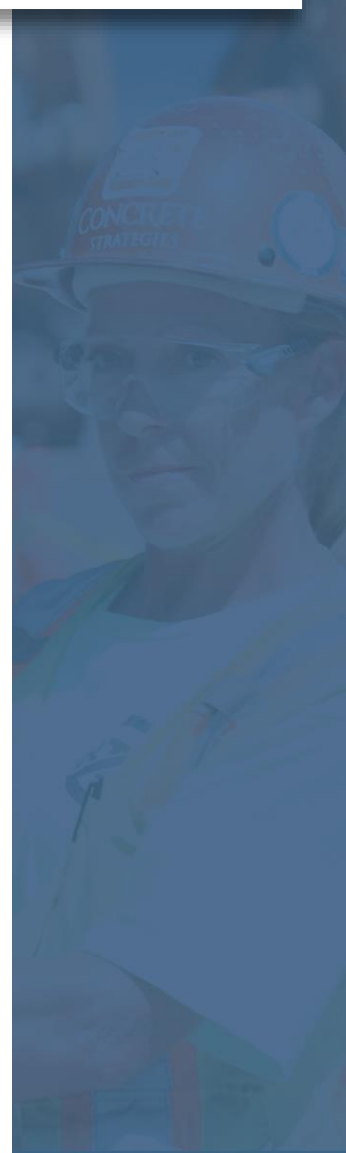

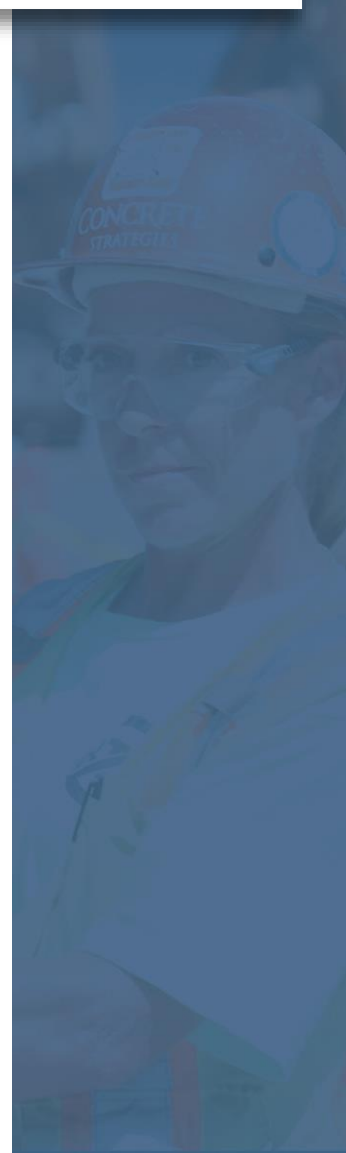
## How it will be Built

- Plating Trenches



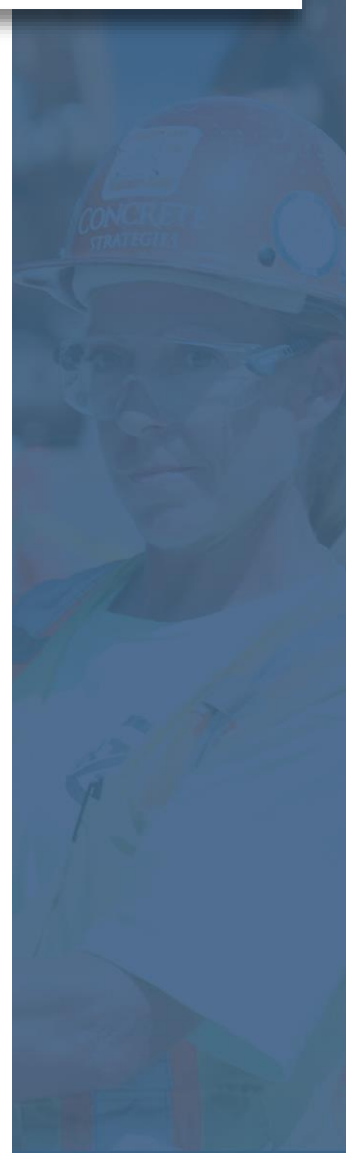
## Restoration

- Will this project affect sewer service or other utilities?



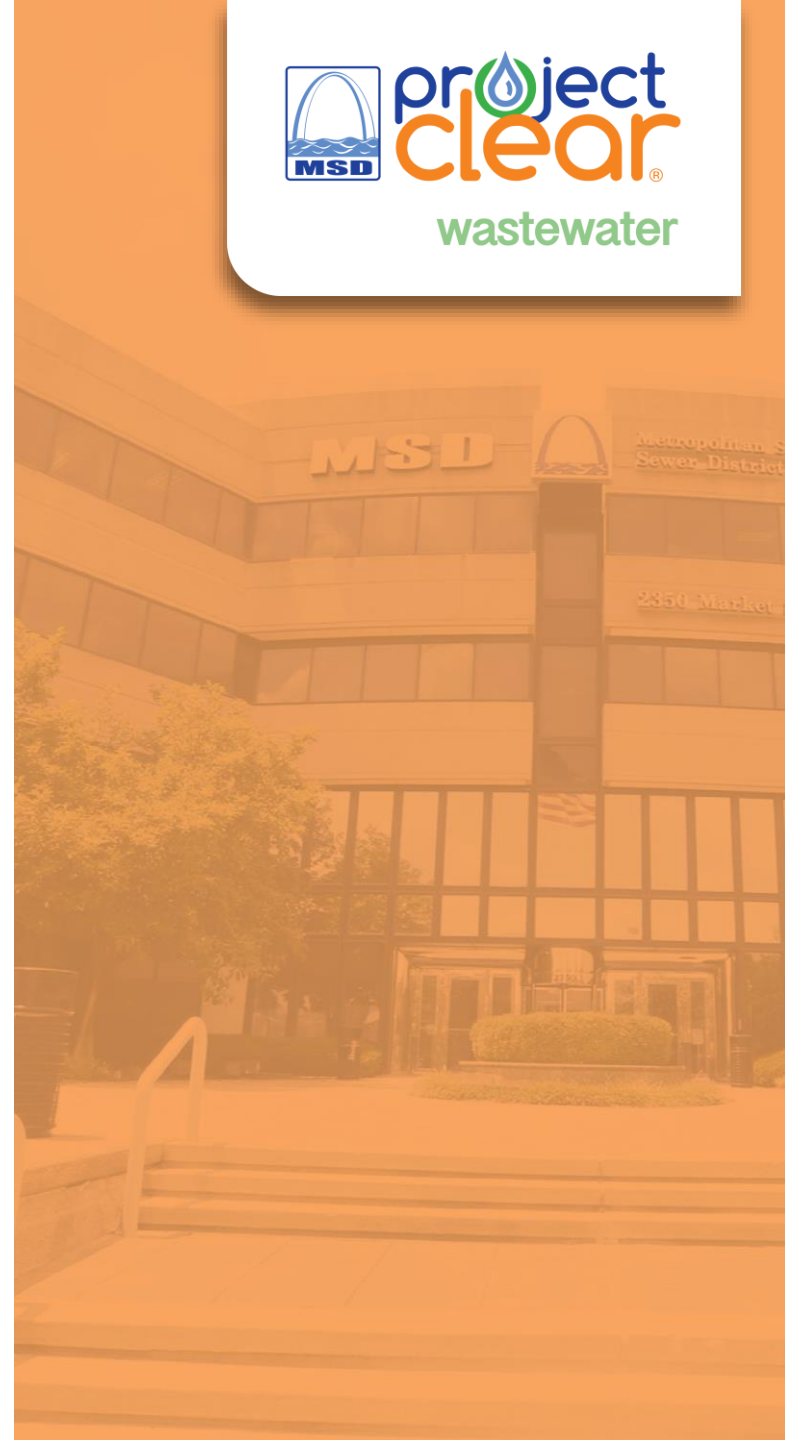
